- I. Call to Order:
- a. The meeting was called to order by Jason Schuepbach at 10:01 am.
 - II. Pledge of Allegiance was recited.
- III. Welcome to all Members New and Existing

Requirements for serving on the Board of Directors

Be a Condo Lot owner or UDI owner in good standing (i.e., accounts current and must remain current on both dues and special assessments.)

Meetings will be the 3rd Saturday of the month beginning at 9:00 am.

Member is required to attend 10 meetings unless excused.

A Board calendar runs from annual meeting to annual meeting.

A letter of intent to run for the Board is required for UDI members by April 15th of the election year. Nomination ballots will be mailed to all UDI with the slate of candidates. Results of the election will be announced at the June monthly board meeting.

A letter of intent to run for the Board is requested for condo owners, but not required, before the annual meeting.

The letters will be posted in the Reservations office and at the election.

Serving on the Board of Directors should be looked upon as a commitment to the association and the park. This is the operating body for the benefit of ALL members. Do not run on a personal agenda. The future of our park depends on the people elected. Think deeply before running and choose wisely when electing a board member. A good board Member should look forward to the future and improvements of our resort. The board of directors must be committed to servicing the membership.

XVI. Election Results:

- a. James Thompson, Board Secretary provides the election results as follows:
 - 1. Chris Schaefgen, 96 votes 3 year term
 - 2. Thomas Fischer, 67 votes 3 year term
 - 3. Thomas Hill, 53 votes 1 year Alternate
 - 4. Bill Wilson, 34 votes
 - 5. Jim Mowry, 28 votes
 - 6. Butch Ridge, 14 votes

XVII. Election of Officers:

President – Jim Cedarwall nominates Jason Schuepbach, Thomas Hill seconds; Thomas Fischer nominates Sid Young, Judi Owens seconds. Jason Schuepbach elected by vote of four (4)

Vice President – Jim Cedarwall nominates Chris Schaefgen, Thomas Hill seconds; Thomas Fischer nominates Judi Owens, she declines. Chris Schaefgen elected by vote of four (4).

Secretary - Chris Schaefgen nominates Jim Cedarwall, Sid Young seconds.

Treasurer – Jim Cedarwall nominates Larry Grorud, Chris Schaefgen seconds; SidYoung nominates Thomas Fischer, Judi Owens seconds. Larry Grorud elected by four (4) votes.

XVI. Adjournment:

a. Jim Cedarwall made motion to adjourn and seconded by Sid Young. Motion carried.
